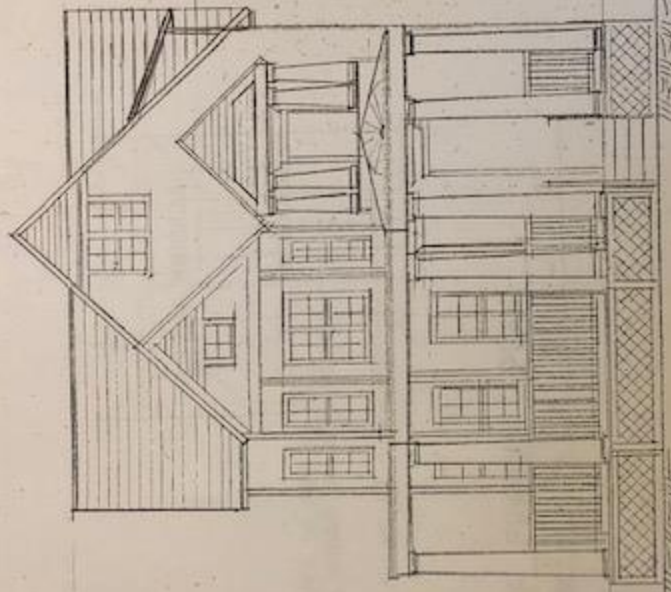

Building Materials:

Asphalt FELT, Asphalt Shingles, Ice & water Barrier.
5/8 ply sheathing, 2x6 Rafters at 16" O/C
5/8 Gypsum board, 2x4 wall plates
Building paper, R49 insulation, R21 unface insulation.
Vinyl siding, 2x6 sistered at point of cut with Rafter hangers on both sides.

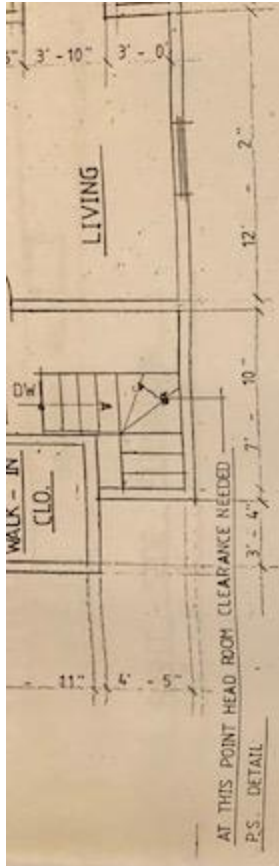

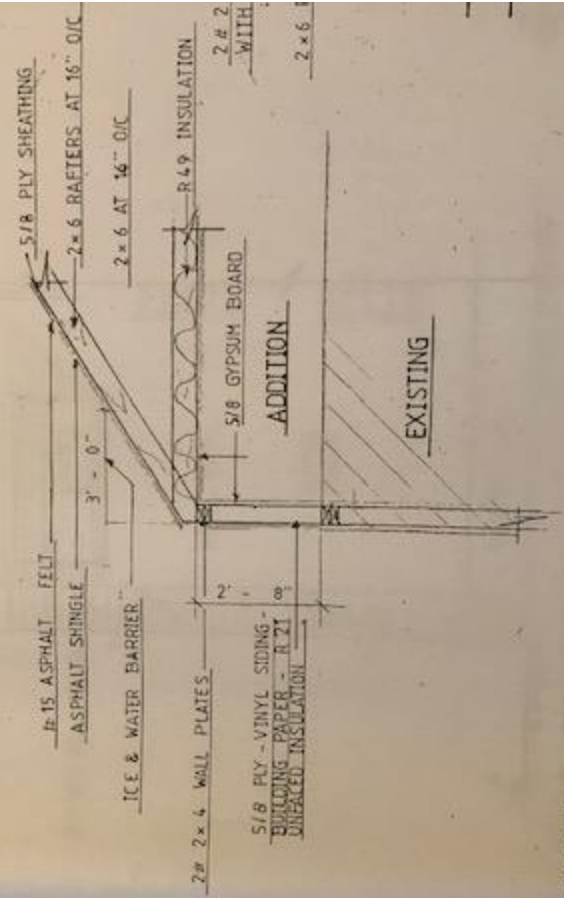


RIGHT SIDE ELEVATION



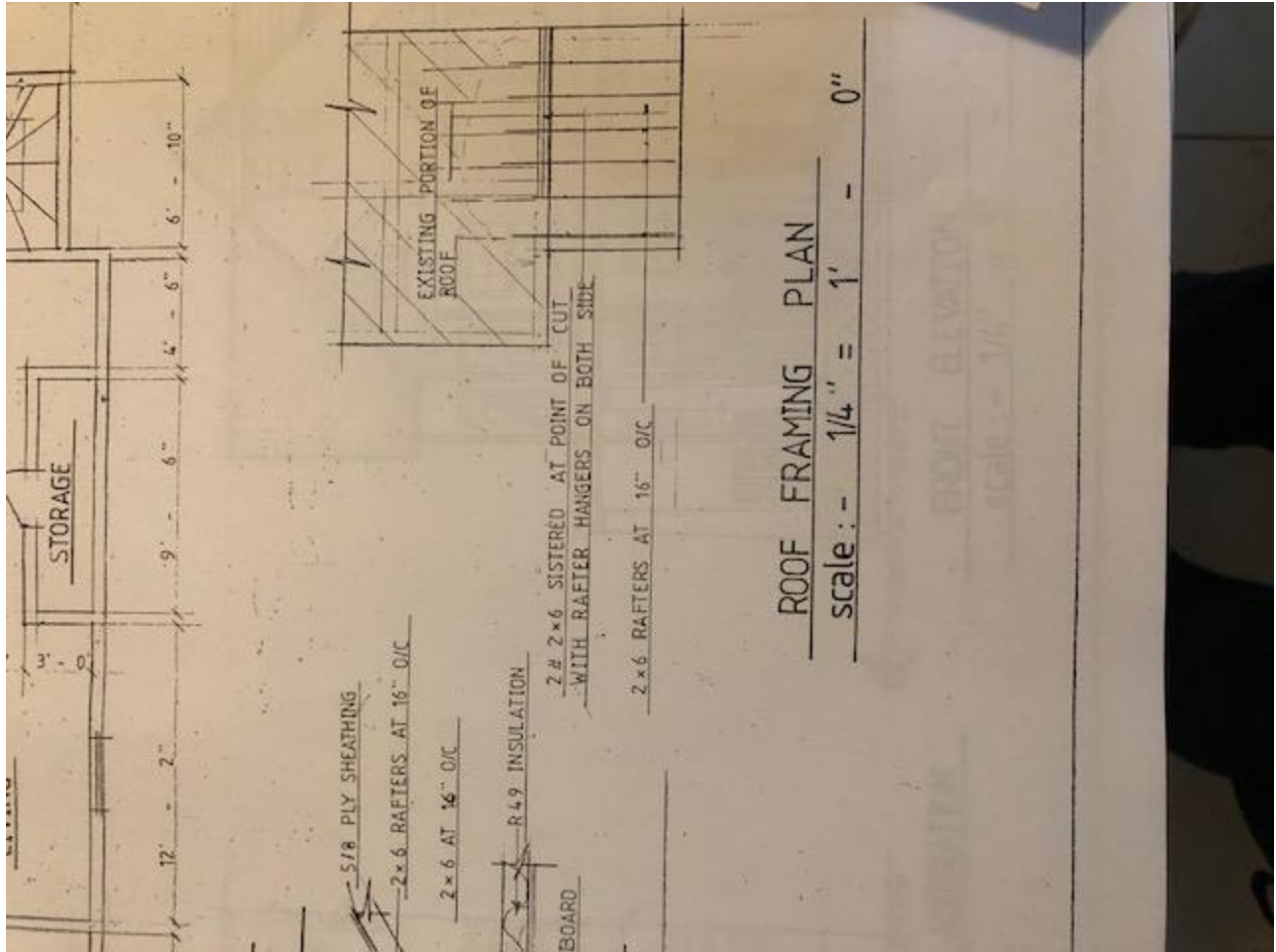
EXISTING 3RD FLOOR PLAN (ATTIC)
