All will be held between 10am -2pm. Flyer was sent out to all 3/27/18. Members of the Connecticut Park and Recreation Association were contacted via a listsery about their experiences with fees and use of MyRec.com. Many provided helpful information and several stated they would be willing to meet with us for an interview.

## River Property Owners – Jeff Devereux

The committee requested that PRAC send a letter to the Mayor and City Council to review and meet with the property owners adjacent to both the North and South Park, but specifically the property owned by the Housing Authority as this area has a trail. PRAC voted to send a letter supporting this request. Tom Baptist, John Gale, Craig Mergins stated they would be willing to work on this project. Grace Yi, from the Sustainability Office was asked to consider this as a project.
