 - b. So far, we have contacted the City Clerk to find out the answers to these questions:
 - i. Were the current bylaws, reviewed on 3/15/00, ever adopted?
 - ii. Party affiliation requirement; where does this requirement stem from? Answer from David Grant: "Please see below for a link to your requested information.https://www.cga.ct.gov/2017/rpt/pdf/2017-r-0344.pdf'".
 - Generally speaking, if there are more than 9 members of our Commission, no more than 2/3 cannot be from the same political party.
 - iii. Will the Commission's by-laws need to reflect the new gender parity resolution?

 Answer from David Grant, November 2020: "Per the city charter, we cannot mandate that each board/commission be composed of no more than 50% from one gender as the Mayor has the ability to select whichever candidates he/she likes. Therefore, this resolution will seek to encourage the charter revision commission to add gender parity language into our city charter thus ensuring more inclusive appointments. However, the charter revision process will not begin until next year, so, immediate nominees are not subject to any gender parity policy."
