same expense predicament that I originally presented to the Historic Committee. As you may know, the cost and maintenance are the reasons why the project was presented to the board. I'm seeking your approval to revise and reconsider using aluminum instead of pvc for the trim. I've attached all quotes from the meetings with the Historic Preservation Board, my contract for the siding, and labor and material quote just for the trim. Based on the last call with the board, it was my understanding that there was an exception to the ordinance in regards to not enforcing these rules if the owner cannot afford the expenses. The call was recorded and I do not recall the woman that spoke up in regards to the rules but it was a major driver as to why siding was approved. Below is the breakdown of how much it would cost if pvc is used for the trim. This cost is relatively cost to all the quotes that are listed to paint or use of the other siding that I cannot afford. 




