Reaching out today as a Behind the Rocks resident. Going to try to keep my input on the plan simple.

#### Move

- 1. I think <u>elevated crosswalks</u> are going to be crucial for making the area more walkable and also have the added benefit of placing a de facto speed bump on the road for traffic calming and reducing ATV's. We need these on Flatbush, Hillside, Fairfield(near goodwin), and New Britain Ave.
- 2. We have a major need for a protected bike lane on Flatbush ave at the intersection of the walmart parking lot, i-81, and the west hartford border. As of right now that area is completely unsafe to bike on and barely walkable, with no crosswalk in front of the parking lot to walmart. fixing this would also fix a major issue of connectivity to the fastrack station closest to many of us on Flatbush ave.
- 3. I would love to participate in the development of the river trail and the green network between parks, if possible.
- 4. I have pointed out to 311 that Brookfield's sidewalks are old, sunken in, and prone to flooding. Making the area completely unwalkable when it rains or after it snows. Is there a plan for that?
- 5. Why not protected bike lanes on New britain ave (and more)? The plan states that there are none, but the action items do not list "adding protected bike lanes." Road diet sounds great, but would like to be clear about that including protected lanes on new britain ave and beyond (flatbush!).
- 6. I support the barriers and barricades part of the plan

#### Green

- 1. Planting more trees sounds good, is there a program where residents can request a tree from the commission or from Knox if they are open to having one on their property?
- 2. The solar action items feel as though they require further clarification, what does that mean? **Live**
- 1. Will the anti-litter efforts include the installation of more public garbage bins? The Flatbush/Brookfield area desperately needs more
- 2. I recently moved from yale st to ellington, where i have several speed bumps around me, and differences in ATV's as a nuisance has been night and day. Road planning seems to be more effective at preventing ATV and dirtbike use than police have been
- 3. Love the idea of opening school grounds for community use during off hours. Breakthrough magnet school south has a massive field that could be easily turned into a soccer field for city residents. Would also love to see Prince Tech's tennis courts fixed and opened to the public
- 1. Would love to have a tennis court at one of our parks

- p. 17 typo in the homeownership. Graphic shows 92%, text says 98%.
- P. 25 graphic is cut off, can't see the whole legend.
- P. 26 tree canopy, can we also add the goal of producing local food?
- p. 28 copy edit, put a period: ...increased property values. Ensuring..."
- p. 29 Can we include people's yards in the pollinator effort?
- p. 32 the chart is blurry and unreadable.
- p. 36 unnecessary dash in "neigh-borhood"

- p. 47 unnecessary dash in "res-taurants"
- p. 49 "quality of life crime" is a problematic phrase that often refers to common behaviors of non-dominant groups. For instance, loitering or the act of hanging out in a small group would be a quality of life crime issue that's basis is in oppression. Yes, HPD and the City use this wording, but that does not make it anti-racist or effective for dismantling white supremacy.
- Would like to see this language removed and adjusted to focus on identifying and providing for community members' needs.
- Ensuring our neighbors have their basic needs met like food, housing, access to healthcare, social connection can drastically reduce real crime and violence.
- Rather than engaging police, we might engage social or medical service orgs, increase knowledge of available social or medical services, identify gaps in access to social or medical services and work to close them.
- p. 50 "Hot spots?" Like places where people hang out and do things that offend people who are different than them?
- Would love to see logical responses to stuff like if Puerto Ricans want to party for one weekend per year on Franklin Ave, close it down and sanction it rather than punishing folks.

The point is that police do NOT prevent crime and they are NOT required to protect citizens. Involving police in neighborhood improvement activities will not reduce crime, protect citizens, or result in any of the promotive outcomes we hope for.

- p. 52 would love to see this goal take priority and be placed before addressing "crime" with the police, as these promotive goals are effective at reducing crime without punitive action.
- p. 53 is there a map of public spaces in our neighborhoods?

p. 59 -

- Improving the pedestrian environment could also include increasing the number of cross walks, installing bus shelters, and putting a well-marked school zone on both sides of batchelder school.
- ensure bikers feel safe has the same actions and partners as the the one above it but they are not relevant to bikes. I would like to see what the actual plan is as this portion is particularly relevant to me.

p. 60

- Would like to see "implement complete streets" on New Britain ave.

p. 63

- Should our "Green Network" also include the City's Parks & Rec department?

p. 64

- Engaging a partner isn't really an action here and if they are engaged with the rest of the city, our work will not be prioritized.
- Want to see clearly marked bike lanes, grade-separated bike lanes where needed, and signage. (No sharrows, and no signage without infrastructure)
- Again, feels like leaning on iQuilt is not strategic.

- Rather than "consider" other opportunities for pocket parks, can we "identify" them?
- Misspelling Parks "Master" Plan

#### p. 67

- Action items for pocket parks
  - Conduct community survey to identify potential spaces
  - Assess viability of suggested spaces
  - Establish neighborhood committee to prioritize and move projects forward
- Action items for Improve access points
  - Establish one annual keystone event in the neighborhood that occurs at a public space
  - Engage local artists and landscapers to beautify open space entrances
  - Engage local organizations to hold public education events within open spaces
  - Add an additional access point to the cemetery for south end residents to access its north side.

#### p. 68

- Typo unnecessary dash in "synergy"
- If we're going to highlight key historical events, we should ensure it is inclusive of indigenous people, their cultures and genocide. Please do not white wash our neighborhood's history.
- Again spelling error, "Parks MaSter Plan"
- Spelling error, ..."improvements"

#### p. 72

- Unlikely to benefit from engaging YSC in admin activities, BUT if we have YSC youth in our neighborhood they might could be paid to participate in the NRZ and one or more of its committees.
- Include:
  - Create set of key messages to promote NRZ and the neighborhood
  - Use messages on social media, in email updates, and other media opportunities
  - Design and implement neighborhood recruitment campaign
- Before we identify potential funders, we could have a committee of folks with the requisite skills to approach, apply to, negotiate with, or receive and manage funding from those groups.

Happy New Year - I'm going to guess this is about to make me the only Hartford resident to read all five of the plans. Comments are these overall look great.

- Asylum Hill Love the TOD language, red light camera, and other related safety language. There are a lot of schools in the neighborhood, could there be a place to add language about "Creating safe routes to schools" explicitly? At the recent Asylum Ave Road Diet plan there was a resident who lives across from West Middle who spoke passionately about how dangerous it is for her kids to cross the street to get to school
- Behind The Rocks Love the New Britain Road Diet language! Definitely needed. As are the increased safe pedestrian and bicycle connections. Potential areas to add:
  - Work with CTDOT to increase bus frequency and stop amenities no language on % of neighborhood without a car. The 39W only runs every 30 minutes during peak and for all intents and purposes stops running at 7:30 and the 41 isn't much better
  - Allow for additional neighborhood retail uses along key corridors to reduce the need to drive out of the neighborhood for basis tasks
  - Would be great to get more specific on bike infrastructure. Like a two way
    protected cycle track on the west side of Brookfield street no curb cuts = easy
    protection! And would connect three schools directly and a few more are not far
    off

I'm pretty sure the things I am concerned about can't really be addressed by this plan.

We are a small group of people with good ideas. It will take a much larger number of people that are willing to get involved to accomplish these goals.

The plan emphasizes New Britain Ave as it should. However, we have other streets in desperate need of traffic calming, bicycle safe lanes, and pedestrian friendly use.

Hillside, Zion, Ansonia, and Fairfield all need attention. I honestly question that the city is prepared to support us in these areas.

We need strong support from HPD, which at this point I question. Bike lanes (example Zion Street) are regularly blocked by parked cars causing real danger to bike riders. Basic driving laws are rarely enforced. I understand that we are short staffed, but this becomes a big issue to the neighborhoods.

As you note The Free Center is a tremendous asset to our community. We need to figure out how that can become more a part of our NRZ.

## Suggested edits to SW/BTR Strategic Plan

There are numerous neighborhood maps that are labeled "Northeast Neighborhood." Pages 27, 45, 59, 82 and 83.

- P.2 The east boundary of the neighborhood is missing.
- p.8 There is reference to 10 Transformative projects, but no projects are listed.
- P. 13 and 33 The garden photo is not in our neighborhood.the only garden in the neighborhood is at Avery Heights. Years ago, there was one on land behind St. George, but it was closed.
- P. 27 The tree density map is not very representative of actual density. Not sure where you got it.
- P. 29 I would prefer that it were more clear that the NRZ would take an active role in promoting tree planting on private property.
- P. 31 The names of partners should be accurate:

City of Hartford Tree Advisory Commission

KNOX, Inc.

Job Corps

And please add DPW Forestry Division and City Forester

- P. 35 The resource map doesn't include a lot of resources that could be added:
  - Non-park green spaces
  - Goldfarb Park
  - Package stores
  - The stores in the Walmart plaza
  - Auto repair shops
  - Nursing homes and similar entities
  - Boys & Girls Club
  - Houses of worship
  - Daycare centers
  - Note that the Free Center is no longer a library.
- P. 45 Not sure whether the church on Oliver Street is still operational or vacant
- P. 57 add KNOX, Inc. as a partner for this.
- P. 69 The NRZ should consider forming a committee or committees to function as friends groups for our small parks. We once did this for Forster Park.
- P. 80 "Neighborhood" is misspelled in a heading.
- P. 82 It would be good to add a page that would characterize the various zones
